Old Business-

- **Motion 110318-01:** Donation of profits from New Year's Eve 2018 to SMRCNA 2020
 - Intent: To help support SMRCNA 2020 by replenishing the financial loss from SMRCNA 2018.
 - Financial Impact: Profits from New Year's Eve 2018 function above prudent reserve. There will be no cost to ASC.
 - Motion passed.

New Business-

- Nominations for ASC Treasurer, Activities Chair, and PR Chair that were included in your December ASC minutes need to be voted on by the home groups, if you have not already, for January 2019 ASC meeting.

 - Intent- To provide seed money for PPACNA to open a checking account.
 - Financial Impact- Profits from function over prudent reserve.

Public Relations- Opened w/ Serenity prayer and readings; 8 addicts present. **MCJ** met 3 times w/ no problems. Meetings on Who's an addict, and What is the NA program. Need meeting schedules and 2 Basic Text. An addict has offered to go in, and will need to meet w/ staff member at jail for approval to go in. **MCC** met 8 times w/ no problems. 15+ inmates attended. 1-2 panel members. Meetings on Step 11, Tradition 11, open discussion, group conscious, and had an inmate speaker. Suggestion brought in reference to workshop speaker at New Year's Eve function. We have an addict willing to do Q&A, however, an inmate will be released by then and

would like to speak his experience with H&I. It was agreed upon, and if he doesn't show then we will still go forward w/ Q&A. Request received from Milan Health Care requesting meeting brought into mental health unit. PR guidelines state addict must have 5 yrs clean. Committee declined due to lack of clean time, and availability. Solution offered that facility take residents to a Kirksville meeting. Letter will be sent to this effect. Motion accepted to donate 3 books to the facility. If more is requested by facility we'll revisit this motion.

PPACNA- Meets after ASC. 15-20 addicts present. Discussed guidelines to adapt to fit the convention needs. Committee voted in temporary chair to conduct business until guidelines are finalized.
