**Motion 050419-01: ASC purchased printer for ASC Secretary.** Basic housekeeping per guidelines. Votes on the floor and 2nd by Magic City. Passed on floor by 7 groups.

**Motion 050419-02:** Made by an addict. Reads: For B&E Printing to print Area Schedules @ \$.10/page. Intent: To replace MCS which relocated their business. Financial Impact: Will not exceed the previous cost of printing schedules. Bring votes back June ASC.

**Motion 050419-03:** PR Subcommittee Guideline Change. Reads: Add to Article VI, Letter A, #1 subsection b (15. Attend RSC quarterly, subcommittee meeting). Intent: To insure the Area has representation at RSC Subcommittee meetings. Financial Impact: 0. 2nd by Never Alone. Bring votes back June ASC.
