- Nominations for ASC Treasurer, PR Chair, and Activities Chair remained open until the end of New Business at December 2020 ASC.

Open Forum

- All from New Way 2 Live:
 - Can homegroups earmark funds for certain things (i.e.: insurance, speaker meetings, parties at homegroup, etc.)? Yes
 - Are ASC budgets subject to review at the group level? Yes, monthly budget reports are in the homegroups mailboxes every month at ASC. Once a year, in October, the new budgets for the ASC are sent to your homegroups with your meeting minutes to review and vote on to bring back to the November ASC.
 - What about Show-Me Regions budget? Regional level budgets are entrusted for review and vote by our Area's RCM & Alt. RCM as trusted servants to make the best decision.

New Business

- **Regional Motions:**
 - **101020-01:** Change guideline 6.4 d second sentence to read – an allowance will be given for meals to be set at the time of travel (approximately \$60 per day). **Motion Failed**
 - **101020-02:** To pay for Zoom format to use as adjunct to the Show-Me Region business meeting only during the months of the business meetings et al January, April, July, and October. Amount being \$14.99 per month up to and not to exceed \$25.00 a month without further consideration of the Show-Me Region body. **Motion Failed**
- **Nominations** for PR Chair, ASC Treasurer, and Activities Chair are closed. Resumes are included in these minutes for homegroups to vote on and return with their GSR to January 2021 ASC. One nomination for PR Chair was withdrawn by the addict themselves.
- **PR: MCC** is not allowing meetings, however, are still requesting literature. Baby Blues were delivered by an addict. **PI:** Website is up to date. Need to remove Together We Can from the meeting schedule as they are currently unable to find another meeting place. Addict is compiling addresses for county entities in our area so that a PR Professional mailing can be mailed. Stamps for the mailing are in the PR box. **Panel Coordinator** Randolph County Drug Court is currently not physically meeting due to COVID-19.
