

Primary Purpose Area Minutes November 6, 2021

Old Business

- RCM/Alt RCM, Secretary, Interim Activities Chair voted on and passed.
- Motions 100221-01, 02, 03, 04, 05, 06, 07 were for ASC operating budgets for all committees, and ASC Executive committee.
- Motions 100221-08, 09, 10, 11 were ASC and Sub-committee guideline changes.
- NYE Function is 12/31/21, and Spring Up & Dance is 03/19/21 speakers are confirmed.
- MCC Annual Workshop was on 10/18/21.

Open Forum/

- Why are PPACNA budgets not included in the ASC Treasurers report? PPACNA is its own business separate from ASC. It stands alone.
- January ASC is on the 1st. GSRs given the decision to either keep it on the 1st which is the day after the function and New Year's Eve or have ASC on January 8th. GSRs voted unanimously to have the January ASC on January 8, 2022.

 - Motion 100221-03: Reads to accept ASC Secretary budget for 2022. Intent is to have an operating budget for 2022. No change to budget from 2021. - **PASSED**
 - Motion 100221-04: Reads to accept ASC RCM Committee budget for 2022. Intent is to have an operating budget for 2022. No change to budget from 2021. - **PASSED**
 - Motion 100221-05: Reads to accept ASC Public Relations Committee budget for 2022. Intent is to have an operating budget for 2022. No change from 2021 budget. - **PASSED**
 - Motion 100221-06: Reads to accept ASC Activities Committee budget for 2022. Intent to have an operating budget for 2022. No budget change from 2021. - **PASSED**
 - Motion 100221-07: Reads to accept ASC AD-HOC Committee budget for 2022. Intent to have an operating budget for 2022. No budget change from 2021. - **PASSED**
 - Motion 100221-08: Guideline Change made by ASC Executive Committee. Reads to accept new resume format. Added #2 "Have you read the area and subcommittee guidelines?". Added #3 "Misappropriated NA funds?". Added #4 "Been removed or resigned from a service commitment?" Intent to have more clarity in the resume. No financial impact. - **PASSED**
 - Motion 100221-09: Guideline Change made by Activities Subcommittee. Reads to accept Activities revised guideline. Intent to have Activities Guidelines coincide with Area Guidelines. Financial impact is the cost to print guidelines for home groups. - **PASSED**
 - Motion 100221-10: Made by PR Subcommittee reads to accept PR Guidelines. Intent is to have PR Guidelines coincide with Area Guidelines. Financial impact is the cost to print guidelines for home groups. - **PASSED**

- Motion 100221-11: Area Guidelines. Reads “Article VIII, Section 9 add Letter G “To contact an ASC Executive Committee member if unable to attend ASC meeting.” Intent is to keep a clear communication between the ASC Executive Committee and the Subcommittees. Financial impact is the cost to print guidelines for the home groups. - **PASSED**
- **PPACNA-** Treasurer’s Report balance is \$5,197.96. All Sub-committee chairs were nominated and elected. Discussed theme for next years convention. Nomination for PPACNA Chair – PASSED. Greetings Family,

Your RCM team attended the Show-Me Regional Service Committee October 9th and 10th. 9 of the 17 areas were represented. If you are sending mail to the region the address must read: Show Me Region – NA, PO Box 45, Columbia, MO 65205.

The insurance policy for the region has been renewed. Any group needing insurance for its location will need to contact the Regional Chair to set up a new insurance policy including meetings that have had insurance in the past. We ask that only meetings that require insurance apply to keep our premiums down.

In open forum the RCM's voted to extend the term of the current RD for one year. This was due to the fact that WSC will not be meeting this year due to health precautions. This was done in the spirit of continuity of service. We did not want to send our current AD to their first WSC without the benefit of experience.

The Ad Hoc committee gave a report on it's findings about the Network for Good we discussed last quarter. After reading the terms and agreements as well as reaching out to the WSC for their experience it was clear that cashing the checks would enter us in a contract that would violate our traditions. They are now researching a way to connect our Facebook page to our checking account which would allow us to accept the donations without entering into any agreement with Network for Good.

The PR committee has been tasked with looking into YAP which is a BMTL based phone line. This has the possibility of reducing the cost some of our areas are currently spending on phone lines. More will be revealed.

The regional budget was discussed and finalized. We received resumes for Alt Treasurer, PR Chair, Writing Steps for Recovery Chair, Outreach Chair, and Campvention Chair. Due to the secretary having COVID-19 the budget and resumes will not be available until next month. I will bring them at that time to be voted on by the groups.

SMRCNA dates are October 21-23.

Next regional will be January 15th and 16th at Drury Plaza Hotel Columbia, MO. Any addict is welcome to attend and we encourage our subcommittee chairs to either attend or send reports to the region.
