RCM Report

May 7, 2022

Greetings Family,

Your RCM team attended the Show-Me Regional Service Committee April 9th and 10th. 11 of the 13 areas were represented. First thing we did was welcome back UKCANA and DHOMA and voted in a new area, the Open Arms Area from the St Louis suburbs.

Motion #2022-0116-01 to adopt the YAP-BLMT and the resume for WSR Chair both passed. The region was able to pass on a \$4,476.22 donation to World. We attended a workshop on the duties and responsibilities of a RCM.

The regional delegate and alternate delegate brought two topics to the region to be discussed. The Southern Zonal was wondering if to save money on boasting a Facebook post would the region be opposed to an addict from Canada being allowed to be the administrator of the Southern Zonal Facebook page. It was opposed on straw pole. The second topic was the World wanted to know if the region would be interested in going to a 3 year conference cycle instead of the current 2 year cycle. It passed on straw poll. Straw polls are only a tool to gauge weather there is interest in continued work on a topic leading to making an official motion. Straw polls are not an approval or rejection.

The ad hoc committee concerning Network for Good has had success in finding a way to get the donations without becoming affiliated with Network for Good. They expect the donations to be collected before next region.

It's that time of the year when we have several positions come open so we have received resumes for Chair, Vice Chair, PR Chair, H&I Chair, Alt Secretary, and Campvention Chair. I will need to collect your group votes at the next area.

To change regional guidelines 5.18 B to read “attend RSC meetings from 1 pm Saturday to close of business Sunday”

Intent : To clarify regional guidelines 5.18

Motion 04102022-01 made by Greater St Charles

6.4-A to read: (old)An annual budget will be submitted by all RSC officers and subcommittee chairpersons for the approval of RSC at the meeting following the annual election of officers. (new) The proposed annual budget will be submitted to all participating areas for review and input no later than two weeks after the July Show Me Regional quarterly meeting.

Intent: To create more transparency and provide greater participation by individual addicts in regional business. It will allow individuals a voice in how monies generated by the 7th tradition will impact their recovery at the regional level.

Motion 04102022-03 made by UKANA

To adapt the “Outreach Ad hoc Committee” guidelines as the guideline for outreach, add at 5.20E in guidelines

Intent:To give guidance to the outreach committee.
