#### **RCM** Report

November 5, 2022

Greetings Family,

Your RCM attended region October 15 & 16, 2022. 16 out of 17 areas were represented at region. There will a Webinar Information on the NAWS Website (na.org) on November 10<sup>th</sup> at 6-6:30 pm for H&I. There were proposed guidelines for the YAP regional phoneline that were passed on the floor for the time being as to have an operating regional phoneline service. The Yap number is 573-367-5713, this number will give addicts access to meeting information and direction. Also has the ability to provide an addict to talk with another addict. There was a Writing Steps to Recovery packet that your RCM has on hand if copies are requested. See your RCM for copies. Our Web Master is no longer willing to be of service in that area of NA. There is a motion for hiring an outside entity to facilitate the regional website.

There are 2 motions for your groups to vote on and 1 motion was passed on the floor of region. Please be sure your group votes are brought back to the December ASC. Motion are as follows:

**Motion 2022-16-01**: Motion reads "change regional guideline 6.4 b to state RCM's will use the following formula to set the annual prudent reserve to be maintained: 25% of the agreed upon RSC operating expenses and sub-committee budgets as well as the regional expenses-any P.O. Boxes for regional and sub-committees, the insurance maintain for homegroups, the contracted hotel amount, the yearly Web Master payment. Anything over this amount will be sent annually in January, by regional treasurer to WSC treasurer. The only exception to this rule will be the expenses of the RD and AD to the WSC which will be estimated and kept on hand 4 months prior to WSC.

Intent: To better clarify amounts that need to be kept on hand at all times to ensure that we uphold our traditions and pay all, expenses on time.

**Motion 2022-16-02**: Motion reads "Add to regional guidelines, under section 5.18 an item labeled H, that states all passwords, user names as well as any/all information pertaining to web-site, billing accounts or any other sub-committee presence on the internet are to be provided to the regional secretary, alt secretary, regional chairperson, regional vice-chairperson. Secretary is then to maintain all information on external hard drive provided for and owned by RSC.

**Intent**: To ensure when information is changed or created the region eliminates the chance or decreases the likely that information fails to be passed on as trusted change.

The next motion has already been passed on the regional floor.

Motion 2022-16-03: Hire a professional web-master at rate of \$480.00.

Intent: To make the missourina.org is professionally administrated and responsive to our needs as a region. PASSED ON THE FLOOR October 16, 2022 14 RCMs passed, 2 Abs.

Our Area was asked if we would be willing to switch from April RSC hosting to January RSC due to weather potential. Will be addressing ASC activities to see if possible. Prudent reserve is set at \$16,409. There was an issue with sending money to NAWS which put the region in a financial bind more will be revealed. If there are any questions pleases see your RCM team. Your RCM has a copy of the regional treasurer's report and budget report for the GSR's to review or for copies if your group requests one.

The next RSC will be held January 14 & 15, 2023 at Drury Plaza Hotel, Columbia East. If you would like to join your RCM team and see if this may be your type of service work you are welcome to come. Also, if your group has any questions or concerns you would like to have addressed at the regional level, please bring them to the RCM team and we will try to get as much clarification as possible for your group.
