- Motion 100122-02: Reads to accept ASC Executive Treasurer's Budget for 2023. Intent is to have an operating budget for 2023. Increase of \$10.00 per the year due to the P.O. Box increase.
- Motion 100122-03: Reads to accept ASC Executive Secretary Budget for 2023. Intent is to have an operating budget for 2023. Increase of \$130.00 in mailing & \$100.00 in supplies. \$30.00 group starter kit. Total increase of \$260.00 for the year.
