Motion# 20220415-1: To change regional guideline 6.3g from: "To set the mileage reimbursement for the Executive Committee and Subcommittee Chairs at 10% of the AAA National Gas Average" to "To set the mileage reimbursement for Executive Committee and Subcommittee Chairs at 5% of the AAA National Gas Average."

1) To reflect actual gas cost

2) To be consistent with concept 11, NA funds are to be used to further our primary purpose and must be managed responsibly.

Motion# 20220415-2 Action house discussion decided not needed at this time.
