- 1. Motion 041325-01: To increase the seed money for SMRCNA from the current amount of \$6000.00 to \$12,000.00. Intent: To better prepare for the bi-annual convention. Action: Y-9, N-2, A-1. (Motion passed on floor)
- 2. Motion 041325-02: To amend the guidelines to address the attendance of the Fellowship Development Chair to the RSC as such: to section 5.18.b add: "The Fellowship Development Chair will attend from 9:30 am on Saturday through close of business Sunday." Intent: So they are available to address the needs of the groups & Areas of the Show Me Region
- 3. Motion 041325-03: Change Guidelines section 6.2.1 from: "All donations are to be made to the RSC Treasurer with a check or money order." To: "All donations are to be made to the Show Me Region with a check or money order, through their respective RCM or mailed to the Regional P.O. Box" Intent: To declare one point of accountability for donations to land and live until further notice.

Motion 041325-01 was passed on the floor so your group will not need to vote on this motion. The 2 resumes and 2 motions will need to be voted on by your group. And your RCM team will take your groups votes at the June ASC. So please remember to vote on them. There was discussion concerning increasing budgets for this year.
